

OFFICIAL RULES AND REGULATIONS
PRIZE: Two (2) Night Stay at Lincoln Way Inn

1. *Sponsor & Time Period.* TAWANI Enterprises, Inc., and Lincoln Way Inn (together, the “*Sponsor*”) with a principal business address of 104 South Michigan Avenue, Suite 500, Chicago Illinois 60603, is the sponsor of this Enter to win prize packages sweepstakes (the “*Sweepstakes*”), which commences at 6:00 a.m. CT on September 2, 2020 and concludes at 11:59 p.m. CT on September 23, 2020 (the “*Sweepstakes Period*”).

2. *Eligibility.* The Sweepstakes is open to residents of Illinois, who at the time of entry are at least 18 years old. No Entrant has automatically won.

3. *How to Enter.* To become a bona fide Sweepstakes Entrant (“*Entrant*”), Entrant must be nominated by a nominator, an individual who is not the Entrant (“*Nominator*”) as a COVID-19 related worker: firefighter, medical, EMT, first responder, or police. The Nominator must fill out the form at <https://www.lincolnwayinn.com/health-care-to-self-care/>. Alternatively, the Nominator may nominate an Entrant for no cost by mailing the entry form with Entrant’s first and last name, email address, and mailing address to: Lincoln Way Inn, 409 N. State Street, Franklin Grove, Illinois 61031. Those entering by mail must complete the entry form with all required information for the entry to be eligible as an Entrant.

All entries must be received during the Sweepstakes Period. Limit of one (1) entry per person. Sponsor is not responsible for lost, late, delayed, mutilated, misdirected, illegible, incomplete or postage due mail or entries, or any computer, internet, printing, typographical, administrative or technological errors or failures associated with the Sweepstakes. Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process or the operation of the Sweepstakes or violates these Official Rules. Entries are subject to verification by Sponsor. Sponsor reserves the right to cancel or modify the Sweepstakes if fraud, technical failures or any other factor beyond Sponsor’s control impairs the integrity of the Sweepstakes, as determined by Sponsor in its sole discretion. In such event, Sponsor reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment.

4. *Prize/Odds of Winning.* Four (4) Entrants will be chosen as the winning entrants (the “*Winning Entrants*”) and will be randomly drawn on September 24, 2020 (the “*Draw Date*”). The Winning Entrants will be awarded a two-night-stay at Lincoln Way Inn to be redeemed before December 31, 2021. Dates are subject to availability and can be affected by, but not limited to, holidays or events. There is no requirement that the Winning Entrants pay the actual shipping or handling fees or any other charges to obtain or use the prize, however, the Winning Entrants are solely responsible for all applicable federal, state and local taxes. Odds of winning depends upon the total number of valid entries received during the Sweepstakes Period. The Winning Entrants will be notified within ten (10) business days after the Draw Date. The Prize is not redeemable for cash and no substitute for any portion of any prize package is offered. The Prize is nontransferable. Should the Winning Entrant be unable to claim his or her prize, his or her entry will be forfeited and another eligible Sweepstakes Entrant will be selected by way of a random draw amongst all remaining eligible Entrants.

The Sponsor reserves the right to substitute any prize package or any component thereof, for a prize package of approximately the same value and reserves the right to change these Official Rules or terminate or withdraw the Sweepstakes at any time, without prior notice.

5. *Consent to Use of Personality/Collection of Personal Information.* By entering the Sweepstakes, each Nominator and Entrant consents to the use of his or her name being published. **Each Nominator and Entrant understands and acknowledges that the Sponsor may contact him or her without prior knowledge as a result of his or her participation in the Sweepstakes. The Nominator and Winning Entrant agrees to participate in post-drawing publicity promotions and to permit Sponsor and its advertising or promotional agencies to use his/her name and likeness in promotional and other materials, without additional compensation or permission, except where prohibited by law. By entering the Sweepstakes, each Nominator and Entrant gives consent to receive marketing materials from Sponsor.** The Winning Entrant will be required to provide personal identification and verification of identity to claim prize.
